## MEDIATION

### Fee Schedule

Mediations are conducted by Matthew Maxwell; a nationally accredited mediator (AMDRAS), registered Family Dispute Resolution Practitioner (FDRP) and a Professional Member of the Resolution Institute, Australia & New Zealand.

We provide a facilitative mediation model using a blended problem-solving and solution-focused approach to dispute resolution. Mediations can occur at venues suitable to all parties (costs met by clients) as well as the Kiama Pavilion Conference facilities (subject to availability.) Secure online meeting platforms are also available at no additional cost.

As a private practice, participation in mediations by lawyers, counsellors, accountants, or other acceptable support persons is available; subject to acceptance by all parties and the mediator.

#### Commercial Mediations

Preliminary Meetings, including:

- Meetings with each participant (up to 1hr pp x 2 parties)
- In-person, online and teleconference options
- Joint preliminary conference call (if required)
- All telephone, online, and other correspondence
- Pre-mediation letters and Agreement
- Consideration of suitability for mediation
- Liaising with support persons
- Facilitating exchange of documents

Mediation, including:

- Joint and private sessions (as determined by mediator)
- Facilitated option generation and negotiation
- Assistance in typing of Agreement, and printing
- Execution of documents by clients (if applic.)
- Up to 5 hours duration

Fee: from \$1800 pp/ 2 party matter)

Additional time: from \$380 /hr

#### Conflict Coaching for Individuals

Individual coaching includes:

- In-person or online consultation options
- Initial session up to 90 mins

Adult session fee: \$140 /hr

Youth (13-22yrs): \$105 / hr

Existing client: \$70 / 30mins

Existing Youth: \$52.50 / 30mins

Packages: \$415 / 4 session package in advance.  
\$310 / 4 session – youth in advance.

#### Family Mediations

Initial Engagement, including:

- Intake meeting with each client (Up to 1.5hrs pp)
- Joint preliminary conference call (if required)
- In-person, Zoom and teleconference options avail
- All correspondence and Section 60I Certificate
- Pre-mediation letters and Agreement to Mediate
- Consideration of suitability for mediation
- Liaising with support persons
- Facilitating exchange of documents as required

Family Mediation, including:

- Joint and private sessions (as determined by FDRP)
- Facilitated option generation and negotiation
- Assistance in preparing an agreement (if applic.)
- Execution of documents by clients (if applic.)

2nd Party Intake Meeting \$ 310

Mediation:

Half Day \$ 940 pp  
Per Day \$1,490 pp

Additional time \$ 190 /hr pp

#### Payment terms

Initial enquiry to discuss requirements – 20 min free of charge.

Initial Engagement fee payable upfront by requesting party and is non-refundable where other party refuses to engage.

Mediation fees payable in advance based on required timeframe, then payable in advance, for extensions.

Travel and accommodation costs (outside of Illawarra & South Coast and Southern Highlands regions) TBD and shared between parties.

Client nominated venue at own costs and arrangements.
